or any representative to any other body or in any other election that may be held.

(c) A member of the Association may move a proposal or bring forward a new business to the Annual General Body Meeting of the Association, provided that, previous notice of at least 14 days has been given in writing to the President. # 9) GENERAL BODY

- (a) The General Body will elect office bearers and members of the Executive Committee.

# 11) QUORUM FOR GENERAL BODY & EXECUTIVE COMMITTEE MEETING & AGENDA

At least 20 members will form the quorum of the General Body Meeting and Special General Body Meeting. In case of Extra-ordinary General Body meeting the quorum shall be 50 members of the Association.

The quorum for Executive Committee shall be one-third of the total members.

In case of non-availability of quorum in the General Body or Special General Body Meeting, the meeting will stand adjourned to the next day. No quorum will be required at the adjourned meeting of the General Body.

#### AGENDA:

Agenda for the General Body meeting shall be approved by the Executive Committee. Only those matters in the agenda shall be discussed in the meetings. Any other matter may be discussed with the permission of the Chair.

# 12) ELECTION

Election of the Office-Bearers to the Executive Committee shall be conducted by the Returning Officer nominated by the President on the advice of the Executive Committee. He/She may be assisted by one or more Assistant Returning Officers nominated in like manner.

These regulations may be altered, deleted or modified at the annual General Body meetings or by a Special General Body meeting convened for this purpose when a resolution to the effect is passed by two thirds of the members present and voting.

# 21) DISSOLUTION/ OR AMALGATION WITH ANOTHER BODY/ SOCIETY/ASSOCIATION TRUST

- (a) If at any time it should appear to the Executive Committee that it is necessary or desirable that the affairs of the Association should be dissolved an Extra-ordinary General Body meeting shall be convened to consider the matter.
- (b) Any resolution under this regulation must be passed a majority of not less than three-fourth of the members of the Association.
- (c) Upon dissolution of the Association, the remaining assets after satisfaction of all its debts and liabilities and property shall not be paid to or distributed amongst the members of the Association or any of them, but shall be given to a similar registered society or the government, to be determined by votes of not less than two thirds of the members present personally at the time of dissolution, or in default by any court of judicature.

#### 22) INTERPRETATION

In case of any doubt regarding the interpretation of any provision of these byes - laws / regulations, the decision of the President shall be final.
